He noted that the decline in profit from \$120 000 last year to \$36 000 this year should be seen in light of the \$76 000 covid payments received last financial year. He also thanked the volunteers for their work which saves the club significant money. The Treasurer also noted the approx. \$17 500 in current sponsorship for the Pro-Am, that our cash deficit is \$9000, and that there are other capital expenditures to come.
